

Several Lions who lived near the area volunteered to help with this distribution. Dee has local contact to help.

LCIF is also in conversation with Ohio CC Kevin and PID Steve on ways to help. You can donate by bringing canned or non-perishable foodstuffs to the convention next month.

Evidently residents were instructed to get rid of all foodstuffs, personal supplies that might be contaminated, and clean & sanitize all household surfaces.

Zone Chairs were asked to get the message out to their clubs to donate some of the following:

Cleaning Supplies (not bleach)

Hygiene Items – toothbrushes, toothpaste, shampoos, personal supplies etc.

Non-Perishable Foods

These could go out yet by the end of the week as they are needed quickly.

#### Lions Assistance for East Palestine, OH - Update (2/26/23)

Through the Ohio Lions Foundation, Lions of District OH4 are providing residents of East Palestine, OH with gift cards to address citizens' immediate living needs.

The initial distribution of gift cards was held on Friday, February 24; the allotment of gift cards was exhausted in two hours time. A successor Lions gift card distribution is set for Wednesday, March 1, 2023 for local residents. These Lions gift cards, totaling \$10,000 to date, are assisting the community in helping meet their needs.

The Ohio Lions Foundation is the disaster relief resource which funds the in-state gift card distribution, as overseen by OH4 Lions clubs nearest East Palestine.

In communication with the East Palestine City Administration, state and federal agencies are providing the community with cleaning supplies, food and water to local residents impacted by the train derailment and its aftermath.

When a powerful earthquake hit Turkey and Syria on Feb. 5, homes crumbled to the ground, hundreds of other buildings collapsed, thousands of lives were lost, with numbers increasing each day, tens of thousands of people were displaced, and communities were changed forever. When natural disasters strike, Lions are among the first to answer. Lions Clubs International Foundation (LCIF) quickly responded to empower their service by awarding a \$200,000 Major Catastrophe Grant to Lions in Turkey. Lions are key figures in their communities and play a vital role in this process. They are responsible for assessing the needs in their district to maximize their relief efforts. LCIF grants enable Lions volunteers to have a greater impact in their communities.

Sight & Hearing / Pilot Dogs

The Ohio Lions Sight & Hearing Foundation (OHLSHF) was set up to help the five Districts in Ohio that do not have resources for cataract surgeries, glasses or hearing aids. We are fortunate to have the Melvin Jones Eye Care Foundation to take care of cataract surgeries and other eye care needs. We also have the Lions Hearing Aid Program to help with hearing aids.

Pilot Dogs has been our greatest donor in OH 4 for many years. A change of command two years ago broke with tradition and is trying to make Pilot Dogs a greater organization to help visually handicapped clients proceed with a better life standard using a guide dog. Executive Director Jim Alloway took over during the pandemic when everything virtually shut down. This year was the first class of 4 students who trained and acquired their Pilot Dog. Jim is determined to upgrade the kennels, training areas and the dormitories that the students use. A quick cleansing of the old dormitories was made with paint, new beds, dressers and other amenities until a new dormitory can be built. The old dormitory was built in 1950's. Jim has also addressed the fact that only 10 % of the students are totally blind and the other 90% are considered legally blind. The monies that the Lions contribute along with other donating entities pay the bills for Pilot Dogs. At one time the Lions were the chief financial donor for Pilot Dogs but now with declining members, we are not.

The monies collected pay for puppy raising, kennels, food, medical care and staff salaries. Bare in mind that they too have many volunteers. An average dog now costs about \$28,000 with training and is still provided at no cost to the student. I have worked with Pilot Dogs for nearly 25 years and have been given three Pilot Dog career change Dobermans over the years. Apache, we raised, Diesel whom somebody else raised and never made it and Cami who was with a student but developed hyperthyroid problems and was turned back in after 5 years of service.

Executive Director Jim has also made the Lion members of Sight & Hearing, Board Directors and we do have a voice in the Pilot Dog Organization. We meet by Zoom or in person four times a year.

Notice is hereby given per Article X of the District OH4 Constitution and Article VI of the By-Laws of five (5) proposed changes to the District 13 OH4 Constitution and By-Laws for delegate consideration on March 25<sup>th</sup> 2023.

**Issue #1** – To Amend **ARTICLE VI, DISTRICT CONVENTION**, <u>Section 1</u> of the By-Laws by omitting words, insert specific titles, and clarifying by descriptive language.

#### **Current wording:**

Section 1. An Annual Convention of the District shall be held in each year prior to the International Convention at a place selected by an incoming officer and his/her proposed Convention Chairperson at a date and time agreed to as per available conditions. Said arrangements will be provided in writing to the current District Governor.

#### Proposed wording = by omitting the strike through and adding the *italic text*:

Section 1. An Annual Convention of the District shall be held in each year to conclude no less than thirty (30)

Days prior to the convening of the International Convention at a place selected by an incoming officer

District Governor, 1st Vice District Governor and 2nd Vice District Governor and his/her their proposed

Convention Chairperson at a date and time agreed to as per available conditions. Said arrangements

place selected will be provided in writing to the current District Governor.

Rational - - to define "who" may make arrangements for the annual District Convention and avoid the confusion of the phrase incoming officer. Lions Club International defines the requirement for annual convention and elected officers. By listing the particular officers that will be District Governor for the required convention – this would specifically define who can make the decisions for a location and program

**Issue #2** – To Amend **ARTICLE VII DISTRICT CONVENTION FUND, Section 2** of the By-Laws by omitting current language in subsection B and inserting a "descriptive" label for funds related to Convention.

### Current wording:

Section 2. In any fiscal year, any balance remaining in the Convention Fund after payment of all Convention Administrative expenses in that year shall:

- A. Be reduced to \$2,500 (and forwarded to the next Convention Chairperson). There is hereby established a Convention Fund, which shall be used to provide for the annual District 13 OH4 Convention. Said Convention Fund shall be maintained under the direction of the District Cabinet, thru the Convention Committee Chair to be appointed annually by the District Governor. At the end of the District 13 OH4 fiscal year the amount in the Convention Fund shall be Twenty-Five Hundred Dollars (\$2,500.00). If at the end of the District 13 OH4 fiscal year the balance in the Convention Fund exceeds \$2,500.00, such excess balance above \$2,500.00 shall be transferred to the Reserve Fund, established in this Article. The Convention Committee Chair and the Cabinet Treasurer are directed and authorized to provide for the transfer of such excess funds. If the balance in the Convention Fund is less than \$2,500.00, such deficit shall be transferred to the Convention Fund from the Reserve Fund. The Cabinet Treasurer is directed and authorized to draw against the Reserve Fund to replace said deficit to the extent that monies are available in the Reserve Fund.
- B. There is hereby established a Reserve Fund, which fund shall be used as an emergency fund for any District 13 OH4 financial contingencies, including, but not limited to, a means to provide a reserve to allow for the maintenance of \$2,500.00 in the District 13 OH4 Convention Fund. Said Reserve Fund shall be maintained under the direction of the District 13 OH4 Cabinet. Expenditures from

the Reserve Fund shall be approved by a two-thirds (2/3) vote of eligible Cabinet Members at any regular or special meeting of the cabinet providing notice of the proposed expenditure is given as provided in the Policy Manual of District 13 OH4 of this Constitution and Bylaws. Such approval is not necessary to cover expenditures needed to maintain the Convention Fund balance of \$2,500.00.

Proposed wording = by omitting current language shown by strike through and add descriptive language as shown in *italic text*.

<u>Section 2.</u> In any fiscal year, any balance remaining in the Convention Fund after payment of all Convention Administrative expenses in that year shall:

- A. Be reduced to \$2,500 (and forwarded to the next Convention Chairperson). There is hereby established a Convention Fund, which shall be used to provide for the annual District 13 OH4 Convention. Said Convention Fund shall be maintained under the direction of the District Cabinet, thru the Convention Committee Chair to be appointed annually by the District Governor. At the end of the District 13 OH4 fiscal year the amount in the Convention Fund shall be Twenty-Five Hundred Dollars (\$2,500.00). If at the end of the District 13 OH4 fiscal year the balance in the Convention Fund exceeds \$2,500.00, such excess balance above \$2,500.00 shall be transferred to the *District Convention* Reserve Fund, established in this Article. The Convention Committee Chair and the Cabinet Treasurer are directed and authorized to provide for the transfer of such excess funds. If the balance in the Convention Fund is less than \$2,500.00, such deficit shall be transferred to the Convention Fund from the *District Convention* Reserve Fund. The Cabinet Treasurer is directed and authorized to draw against the *District Convention* Reserve Fund to replace said deficit to the extent that monies are available in the *District Convention* Reserve Fund.
- B. There is hereby established a *District Convention* Reserve Fund, which fund shall be used as an emergency fund for any District 13 OH4 financial contingencies, including, but not limited to, a means to provide a reserve to allow for the maintenance of \$2,500.00 in the District 13 OH4 Convention Fund *and for other documented convention expenses*. Said *District Convention* Reserve Fund shall be maintained under the direction of the District 13 OH4 Cabinet. Expenditures from the *District Convention* Reserve Fund shall be approved by a two-thirds (2/3) vote of eligible Cabinet Members at any regular or special meeting of the cabinet providing notice of the proposed expenditure is given as provided in the Policy Manual of District 13 OH4 of this Constitution and Bylaws. Such approval is not necessary to cover expenditures needed to maintain the Convention Fund balance of \$2,500.00.

Rational - - to add *District Convention* to the (current listed) Reserve Fund so it makes it clear that the District OH4 Convention is the only place these funds can be used for and remove language giving reference to other possibilities.

**Issue #3** – To amend **ARTICLE IV, Section 2, sub-section C** of the Constitution to permit "electronic means" of meetings and define quorum and voting rights.

Current wording: Article IV DISTRICT ORGANIZATION

Section 1 Cabinet & Officers is unchanged

Section 2 District Cabinet Meetings

A. **Regular** A regular meeting of the Cabinet shall be held in each of the first three quarters of the fiscal year, with the first to be held before the end of August, and a fourth meeting held in conjunction with the annual district convention. At least fifteen (15) days written or electronically transmitted notice of meetings setting forth a date, time, and place determined by the District Governor shall be given to each member (of Cabinet) by the Cabinet Secretary.

B. **Special** Special meetings of the Cabinet may be called by the District Governor at their discretion, and shall be called upon written (including letters, electronic mail, or facsimile transmitted) request to the District

Governor or the Cabinet Secretary by a majority of the members of the Cabinet. Not fewer than five (5) nor more than fifteen (15) days written (including letters, electronic mail, or facsimile transmitted) of special meetings, setting forth the purpose thereof and a date, time and place determined by the District Governor, shall be given to each member (of Cabinet) by the Cabinet Secretary.

C. **Quorum and Vote** The attendance of a majority of the members of the Cabinet shall constitute a quorum for any meeting thereof. In all such meetings, no voting member of the cabinet shall have more than one vote on any issue.

Proposed wording: Insert new language as printed in the MD13 Constitution as shown *in italic text* and omitting most of current language shown by strike through.

Section 1 Cabinet & Officers is unchanged

Section 2. District Cabinet Meetings

- A. Unchanged
- B. Unchanged
- C. Quorum and Vote The attendance of a majority of the members of the Cabinet shall constitute a quorum for any meeting thereof. The District Cabinet shall meet at such times and place as may be fixed by the District Governor, and the personal and/or electronic presence of a majority of the members of the Cabinet shall constitute a quorum at any meeting. In all such meetings, no voting member of the cabinet shall have more than one vote on any issue.

Rational - - to permit without controversy electronic meetings and formal actions which may come out of those meetings. Electronic examples are ZOOM, Teleconference, SKYPE, etc.

**Issue #4** — To amend **ARTICLE IV, RULES OF CONVENTION PROCEDURES — Section 1** of the By-Laws to remove current restrictions.

### Current wording: ARTICLE IV RULES OF CONVENTION PROCEDURE

<u>Section 1.</u> The District Governor, along with the District Convention Chairperson and Parliamentarian, shall help arrange the Order of Business for the District Convention and the elections, and the same shall be the order of the day for all sessions.

All business and nominations, if any, will be completed at the Saturday Business session (including votes on resolutions). Sunday's business session is to be for Elections of Officers, committee persons and Trustees only.

- Section 5. Unchanged
- Section 6. Unchanged
- Section 7. Unchanged

Proposed wording: Omit current language as shown by strike through

Section 1. The District Governor, along with the District Convention Chairperson and Parliamentarian, shall help arrange the Order of Business for the District Convention and the elections, and the same shall be the order of the day for all sessions.

All business and nominations, if any, will be completed at the Saturday Business session (including votes on resolutions). Sunday's business session is to be for Elections of Officers, committee persons and Trustees only.

#### Section 7. Unchanged

Rational - - Our District is one of the few to have a three (3) day convention. With raising costs and facilities unwilling "to sign" extended contract without guarantees, this will permit a less than three (3) day convention, if so choose, with the business and election orders to be determined according to allotted time.

**Issue #5** — To amend **ARTICLE VII of the BY-LAWS** to permit "electronic means" of disseminating the Constitution and By-Laws.

#### Current wording: ARTICLE VII EFFECTIVE DATE OF DOCUMENT

This Constitution and By-laws shall take effect, by the affirmative vote of two-thirds (2/3) of the votes cast, at the close of the District 13 OH4 organizational meeting held October 25, 2015 and be in full effect with the 2016-2017 Lions year.

Starting with the Lions year 2016, the District Cabinet at the time so determined, will be responsible for printing a new/updated/revised edition of the District Constitution and By Laws every three years with each club and current District officers receiving such by December 31 of that year so determined.

Proposed wording: Omit current language as shown by strike through with additional/new language in italic.

This Constitution and By-laws shall take effect, by the affirmative vote of two-thirds (2/3) of the votes cast, at the close of the District 13 OH4 organizational meeting held October 25, 2015 and be in full effect with the 2016-2017 Lions year.

Starting with the Lions year 2016 2022-2023, the District Cabinet at the time so determined, will be responsible for printing a new/updated/revised edition of the District Constitution and By Laws every three years, as needed, with each club and current District officers receiving such by December 31 of that Lion's year so determined. Hereafter, the District Cabinet will be responsible for publishing a new/updated/revised edition of the District Constitution and By Laws with each club and current District officers receiving such of that year so determined by electronic means (ie: direct email, messaging, web posting, etc).

Rational - - efforts to save printing and postage costs along with the possibilities that the document can be revised/updated/distributed at any time, as required.

The meeting was presided over by Zone Chair Cathy Price of the Canfield Lions Club, assisted by acting president of the Austintown club PDG Bob Whited. Special guests included First Vice District Governor Janet Christian of the Calcutta Lions Club and Second Vice District Governor Bill Humphrey of the North Canton Lions Club.

Special Excellence awards were presented by Past District Governor Judy Young of the Poland Lions Club to Austintown, Canfield, New Middletown and Youngstown. This was a new membership award. All clubs gave their reports on their recent activities and fund raisers. Other discussions were of the upcoming District Convention to be held March 24-26 at the Holiday Inn in Canton, and many more future happenings and activities.
